Dear President Deluna:

Pursuant to Memorandum Circular No. 2018-1 dated 28 May 2018 "Guidelines on the Grant of the Performance-Based Bonus for Fiscal Year 2018 under Executive Order No. 80 s. 2012 and Executive Order No. 201 s. 2016," the Commission on Higher Education is the oversight agency for state universities and colleges (SUC) on the grant of Performance-Based Bonus (PBB). Specifically, the CHED is tasked to evaluate the accomplishments of SUCs in relation to the Program Expenditure Classification (PREXC) indicators and the corresponding targets that were published in the 2018 General Appropriations Act.

Relative to this, the CHED through the Office of Institutional Quality Assurance and Governance (OIQAG) has reviewed the accomplishments of **Romblon State University** based on the documents forwarded to the CHED by the AO25 Secretariat. It was observed that the results of evaluation cannot be finalized due to the following:
